RECREATION FEES AND CHARGES

BYLAW NO. 1462

A Bylaw to establish recreation fees and charges.

WHEREAS, under the authority of Section 194 of the *Community Charter*, Council may, by bylaw, impose a fee or charge in respect of all or part of a service of the municipality to cover costs as necessary;

NOW THEREFORE, the Council of the Town of Smithers, in open meeting assembled, hereby enacts as follows:

1. CITATION

Bylaw No. 1462 may be cited as "Recreation Fees And Charges, Bylaw No. 1462".

2. REPEALS

This Bylaw repeals "Recreation Fees and Charges, Bylaw No. 1301", and any amendments thereto.

3. RECREATION FEES AND CHARGES

a) Fees and charges to provide municipal recreational works and services shall be due and payable upon receipt of goods and/or services as specified in Schedule "A" attached to and forming part of this bylaw.

b) The Mayor, Chief Administrative Officer or designate may waive in whole or in part any fee or charge or refund any fee or charge.

c) The Mayor, Chief Administrative Officer or designate may recover any recreation fees or charges for different business activities affecting property or recreation including recreational services performed outside the municipality.

4. EFFECTIVE DATE:

This bylaw comes into effect on the date of adoption.

5. SEVERABILITY:

If any section, subsection, sentence, clause, or phrase in this Bylaw is for any reason held to be invalid by a decision of any Court of competent jurisdiction, the invalid portion thereof shall be severed and the decision that it is invalid shall not affect the validity of the remaining portions of the Bylaw.

- b) **Late Departures:** Arena Users must vacate the Smithers Civic Centre dressing rooms no later than ONE HOUR after their ice time is completed (i.e.: no later than 1:15 am if the ice time ends at 12:15 am). If dressing rooms are not vacated within the one-hour time slot, extra charges will be invoiced to the organization in one half hour increments.
