2. For applications received before October 2, 2026, the Chief Election Officer will have the package ready for distribution on or around October 5, 2026.
3. You are responsible for ensuring that your completed ballot and any supporting documentation is received at Town Hall no later than 4:30 p.m. on Friday, October 16, or delivered to Muheim Elementary School, 3659 3rd Avenue, no later than 8:00 p.m. on Saturday, October 17, 2026.
